The 10-month Commitment rate will be:

___ **\$149/per month for a 90-minute class (once per week)**

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

___ **\$129/per month for a 60-minute class (once per week)**

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

___ **\$119/per month for a 45-minute class (once per week)**

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

___ **\$79/per month for a 30-minute class (once per week)**

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

I _____ understand by agreeing to the terms of the 10-month commitment I am responsible for the monthly rate beginning with the first month upon registration plus the 10-month commitment investment fee of \$29. I understand I am committing to a monthly pay rate for 10 months. I may change my class day and/or time at my convenience contingent on availability.

If my child chooses another program and/or class with a different instructional (class) length my monthly commitment rate will be adjusted to reflect the new rate for the remainder of the commitment period. If my child is promoted to the next class level due to age and/or skill level I will be responsible for the potential increased monthly rate (if the class length increases) for the remainder of the commitment period. Class days/times are subject to change.

If I choose to exit the 10-month commitment agreement for any reason I will be responsible to pay the month-to-month rate for the months already attended. The difference will be due at the time of withdrawal.
