

## 7-Month Commitment Discount: Agreement Contract

The 7-month Commitment rate will be:

**Initial** the box to indicate the length of class & monthly discounted rate

\_\_\_\_\_ \$159/per month for a 90-minute class (once per week)

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

\_\_\_\_\_ \$139/per month for a 60-minute class (once per week)

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

\_\_\_\_\_ \$129/per month for a 45-minute class (once per week)

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

\_\_\_\_\_ \$89/per month for a 30-minute class (once per week)

your payment will be processed on the first of each month using the credit card on your account. Billing will automatically convert to the month-to-month rate upon the completion of your contract. It is your responsibility to either renew the commitment (if available), continue at the month-to-month rate or drop your class by filling out a drop form at the end of the commitment period.

I \_\_\_\_\_ understand by agreeing to the terms of the 7-month commitment I am responsible for the monthly rate beginning with the first month upon registration. I understand I am committing to a monthly pay rate for 7 months. I may change my class day and/or time at my convenience contingent on availability.

If my child chooses another program and/or class with a different instructional (class) length my monthly commitment rate will be adjusted to reflect the new rate for the remainder of the commitment period. If my child is promoted to the next class level due to age and/or skill level I will be responsible for the potential increased monthly rate (if the class length increases) for the remainder of the commitment period.

Class times/days will change during the months of July and August; a reduced class selection is offered and excludes weekend instruction. The schedule is flexible allowing for a total of 8 classes/clinics throughout July and August. I am responsible for pre-registering for my classes, my account will be charged the discounted rate on July 1<sup>st</sup> and August 1<sup>st</sup> (if my commitment spans those months) *even if I choose not to participate in the summer flex instruction.*

If I choose to exit the 7-month commitment agreement for any reason, I will be responsible to pay the month-to-month rate for the months already attended. The difference will be due at the time of withdrawal.
